4. Executive Reports

4.1 President 's Report – Sarah Kohut

So, we put that forward to the committee recommendation that they should pick that up next year. Because obviously the year is coming to a close very quickly. And Matt and I attended a President's Advisory Committee on the budget meeting, and I just want to flag as well. I shared it on STUSU's story, but the budget town hall will be happening next Wednesday at 4pm. This is a budget town hall for the like the entire university community students, faculty, staff, everyone to get to know the university's budget asking questions and take a look at what the financial picture has looked like this past year. So, I really encourage everyone to attend. It's really informative, especially if you're curious about the university's finances. And they've got some good information in that, or what they will be presenting at that budget town hall. And it's a great chance to ask lots of questions. So, I would strongly encourage everyone to attend. You can find the Microsoft Teams information in your email. It got sent out as a student notice email, I think last Friday, or Thursday. Anyway, so Matt and I attended that where we talked about the budget town hall. And then I think, yes, Matt and I did an interview with the Aquinian about voter turnout in the

7.1 Strategic Plan

Sarah: So, we will get started on this, also just a forewarning to everyone that this meeting will be more of a longer one. So just giving you folks a forewarning of that. So, I'm putting in the chat here, the current strategic plan. And then I emailed out the draft plan to everyone. So, the current plan, if everyone wants to reference that, it would just be the first 1 2 3 pages that are missing from the draft of the strategic plan that the execs created, but those will be the same. So, I just wanted to give that to everyone not identically the same, it'll be different writing. I don't want to plagiarize Brianna Workman's writing. That's just what the start of the document will look like. And then as I mentioned before, so we'll be going over the proposed or not proposed the rough draft of the strategic plan right now, getting everyone's feedback, then the executives will go and make some changes, implement that feedback. Then at our next SRC meeting, we'll present it again, the full document, with the graphics all done, all the pages in it, everything looking spiffy, and then ideally, it'll be passed at the next meeting. So that's just a bit about the procedure going forward. So, I would ask everyone to pull up the draft of the strategic plan. So, you'll see that there's

So, in the interest of everyone's time, I'm not going to go through all of the changes that we made. I'll just ask everyone for your feedback. And hopefully everyone had a chance to read it over and if you have any opinions or comments. And I will also add as well that we, Tiger, and I spoke a few weeks ago about getting the Reconciliation Committee's feedback on this as well. Obviously, as I'm sure you're all aware, they've been quite busy with the series that they're putting on right now, which is fantastic. So that hadn't happened yet. It will happen. I'll make that a priority to get that feedback. But I'm just throwing that out there now that this was drafted without that feedback. So, I will put it out on the floor now. I know it's kind of a big document. It's a dense document. No question is a stupid question. So, if anyone has any questions about like, what is the purpose of a strategic plan again, I forget or like, why is this included in here? Or what was the rationale behind writing this? Just any and all questions would be fantastic. Because even though this is the executive's kind of doing the work and writing it, this is a product of all of us of all of us so obviously the executives, we really want to hear your feedback, and make sure that it's something that everyone is happy with.

Sydney: Just a question about the core objectives. Why did you cross out the first line where it says: STUSU shall ensure its operations are accessible, accountable, and transparent to St. Thomas university students to ensure that the organization can fully understand and meet the needs of its membership?

Sarah: Yes, thank you for that, that was crossed out. And because the executives decided that we wanted to make that an entire priority in its own. So that was like, the only mention I guess, of transparency was in the current strategic plan was under the enhancement of the student experience. But the executives are like, we think this is really important to pull out and make it its own thing. So that's why it was crossed out. But I just wanted to reflect that change, and then kind of give the chance to speak to it in a meeting so that everyone's aware. I also want to add as well, just like also giving a bigger picture, I was going to mention this at the end of the meeting, but I think it'd be worthwhile to bring up now is that, ideally, like I said, this would be tabled today. And then anyone, people have the chance to look it over one last time after today. And then it's passed with the changes we discussed today next meeting. However, we're in a little bit of a pickle because we, in theory, have three meetings left of the school year. But our third meeting on April 4 falls on a long weekend on Easter. So, I don't think that any of us want to be having a meeting on a long weekend. So that's why ideally, it would be great to have this passed next week. However, if it's not, and I want to give the opportunity to give everyone like a chance to read this over to give their feedback to make sure it's something that everyone's confident and happy with. So, if it's not able to be passed next week, then we would look at the possibility of rescheduling our meeting that would happen on the week of the fourth to the 10th. Because we do need to have an SRC meeting to pass this and get everyone's approval. So that's also just a little bit of context here of why like the timeline that we're working with. And I also want to add as well, this timeline isn't any different than what it usually would be. When we passed the current strategic plan that we're working with. We did it I think on the second last meeting of the school year. So, this timeline is right on par with what we usually do. It's just unfortunate that our last meeting falls on a holiday. And that kind of messes things up a little bit. I would really encourage you folks to before next meeting, have a really good hard look at this. And if you don't have any comments, that's totally okay. But again, I've said this 100 times, I just want to make sure that everyone is okay with the things that are in this document. And that everyone's happy with it because it is a product of all of us. So obviously, you want to make sure everyone's happy with it. And something that also can be done is like, if anyone has any things that they notice, or they want an explanation on, please feel free to send me an email and I'd be happy to discuss that or to set up a meeting entirely. But I will say that if there's any big changes that are being made, I would want all of SRC to have an opinion on that. So, if you have any questions about the content, please feel free to email me. But if you have any like large changes, like you say like I want to take out this entire priority, then that's something that would have to be done with everyone's feedback. However, what I was saying on that point is that this isn't the only opportunity to give feedback either. Next meeting, what can be done is when documents are passed like this, you can have something with friendly amendments. So, it basically means that like,

what you're passing is inclusive of the changes that are agreed upon in that meeting. So, like, this isn't your only opportunity to get feedback next week, there will be the opportunity to do so. And then we could pass a document with friendly amendments and include what's talked about next week. So, all that being said, I encourage everyone to take a good look at this document. And let me or any of the executives know if you have any questions in the meantime, or anything, and that's what we're here for to answer them. And then one next week, you'll see this document, looking all pretty. I'm going to pull out my Canva skills and make some nice graphics and stuff and letterheads and whatnot. And then you'll see the officially completed document. And I think that is all. Also, if anyone has any questions about like the procedural stuff about this, like, can you remind me what we're doing next week again? Or like, like I said before, why does this document even exist? Please feel free to reach out. No question is a dumb question. This stuff is really dense and can be quite confusing. I remember I was kind of confused when I was in my first year on Council, and we were passing the current strategic plan that we have.

Motion has been moved by Madam President to table agenda item 7.1 until the next SRC meeting. Seconded by Tiger L.

That motion has been approved by all present 11 voting members of council.

7.2 Annual General Meeting

Kyle: I will try to make this one quick, just because there's still a couple of things left on today's agenda. But basically, I just wanted to briefly talk about the AGM, the annual general meeting, as well as the AGM ad hoc committee, like what that does, what it looks like, what the commitment looks like all that. Should you guys be interested in helping myself and Valeria to the awards for the AGM. So basically, the annual general meeting is typically the last or one of the last things that we do together, including the employees if they want. When happens in person, there's usually also like a meal that's catered and like a whole night is made out of it. However, because our AGM is going to be virtual, there's, of course not going to be a meal this time around unfortunately. I just wanted to remind you all before I go into it to please not forget about the doodle poll that I sent out Friday afternoon, just so that I can pick a day that works best for the most people. And so basically, the AGM is a formal or semi formal meeting that happens at the end of the year, where speeches like short speeches are given from the outgoing executive and the incoming president. And then there's also an awards presentation and a mock awards presentation. So, the mock awards are for everyone on SRC. And then the other AGM awards are for the entire student body for the most part. So basically, it's just time that set aside to celebrate the year that we had and the accomplishments that were made throughout the year. And because of COVID, and like the extra hard year that you know, we've all had in all of our roles and as students, celebrating this is definitely like an important thing to do. But awards are going to be presented on social media directly after they're announced at the AGM. The date is still to be determined; I will be probably sending you all an email once. Mostly everyone fills that out. But similar to last year, the awards are going to be presented on social media right after the AGM. And then the award winners are going to be emailed their certificates that same evening as well. So that's pretty much it, surrounding like the AGM itself. And now I just want to touch on the ad hoc committee, which is the committee that helps Valeria and I choose the awards themselves, which isn't a huge commitment at all. So, if you're interested in being a part of this ad hoc committee, please, please, please send me an email. It would be absolutely lovely to have whoever on board if you're interested. But basically, the ad hoc committee is going to be meeting twice before the AGM, I've decided. The first meeting, and these like the dates aren't set in stone yet either. But the first meeting is just going to be going over the awards and processes, how everything is going to work. And then the second meeting with the ad hoc committee is going to be choosing the awards themselves. So, if you're interested in being on that, then like I said, feel free to hit me up. But that being said, because it's not an active committee right now, just for the understanding's sake of it. Ad Hoc means like whenever needed, or whenever necessary, if those words are foreign to you, but please just shoot me an email if you're interested in being a part of that. And before moving the motion, I just wanted to check in with you all if you had any questions about what that the ad hoc committee or the AGM or anything like that. And yeah, that's pretty much it.



Sarah: Yeah, I just want to emphasize what Kyle said, When Kyle and I were on the ad hoc committee, or we were running the ad hoc committee together last year, we did all the awards, and I think in one meeting. So, it really, really is a very, very low time commitment. And honestly, it's a fun time because you get to read applications, and read nice, wholesome things that people say about other students. And that warms my heart. So, I would encourage everyone to get involved.

Motion has been moved by Vice President Student Life to strike an ad hoc committee for the Annual General Meeting Awards for the remainder of the semester. Seconded by Sarah K.

That motion has been approved by all present 11 voting members of council.

7.3 Bus Pass

Matt: So, hi, again, everybody. As I mentioned, we met with Fredericton Transit, the city of Fredericton and Reg from financial services on Wednesday to discuss the bus pass. So, this is something that is gonna have to be dealt with fairly quickly before the end of the year. So, there's a lot of stuff that goes with this, I guess I'll just start with kind of the basics of where we stand right now. So, our contract with the city and Fredericton Transit, it was a two-year contract, and it's expiring this year. So that means that we either have to choose to renew the contract with new details, or not go with Frederick Transit at all. But I'm assuming most people want a bus pass. And that's the opinion that we kind of have as of right now. But basically, because of COVID, this year, a lot of you probably got reimbursed a certain amount of money from the bus pass, that was kind of a clause that was put in because a lot of people were paying for the bus pass but weren't actually in the Fredericton area. So, we kind of talked with them about putting that clause in there, just to kind of reimburse some people. Because obviously, if they wanted to use the bus pass, they wouldn't be able to because they were out of province and stuff like that. But basically, right now, we're negotiating with the city of Fredericton. And Reg is also involved from the university about a new contract. So basically, we discussed whether we wanted a bus pass or no bus pass, whether we want to opt in or opt out and the pay structure that will come with that. And then just the larger pricing structure as a whole. So, I guess Sarah and I did discuss previously, it would be good to have an opt out or opt in system for bus pass, the same kind of thing as Campus Trust. But the thing with that is that we discussed in the meeting is that if we chose to try to provide an opt in opt out clause of the contract, the price would go up substantially for each to have a bus pass. So right now, I believe it's around \$100, if we were to kind of have an opt out in the contract, it will go up to at least probably \$175. And then if we chose to push for an opt in the clause of the contract, that would cost over \$200 per student. So basically, it would be double the price. And the thing is that it's kind of understandable because they have to make a certain amount of money, and their buses still run the same routes, even no matter how many students are paying for the bus pass, stuff like that. So, with the universal bus pass, they can get by with charging the \$99, it's like \$11 a month. Whereas with the opt in and opt out, they may only have four or five students, which would mean that they're not making as much money but still running the same routes on a daily basis. So that's why they would have to charge more, if you have any questions about that I can explain further later, took me a while understand as well. But basically, I wanted to bring this up here because we need to have a proposal to them on what we want for next year by Wednesday. And they put a few offs on the table at the meeting. And in our second meeting on Thursday, Sarah, and I and then Megan and Kyle kind of agreed that the best option as of right now, because we still don't know what next year is going to look like would be to renew the terms of the last two years, which it wouldn't change, it would be the same price for this year. And then it would gradually go up over the years that contract because they do want to get to \$165 for the bus pass over the next three years or so. But basically, for year, we thought that it might be the easiest option, considering the circumstances that we don't know how COVID is going to act for next year to just renew this and potentially have a sort of COVID clause in the contract for next year, kind of the same as this year. And then after that two-to-three-year term, there'll be more like statistics and kind of stuff on how we could possibly save money and stuff like that by using the bus and who uses it, all that kind of stuff. But that is what we thought. But I wanted to bring it to SRC to see who had opinions on whether they wanted to opt in

or opt out. But we just thought that we're doing right now with a COVID clause would be easiest considering the kind of the constraints we have because obviously, we're going to be leaving as executives on May 1, and the City Council is also doing an election right now. So, they want to get done and brought to City Council before that happens, which is around the same timeline, but it's in April, so we only have so much time to kind of deal with this before May first. So that's kind of the basis of where we're at right now with that and I'll let Brianna open it up for discussion to see if anybody has any opinions on that.

Tyler: I think I would still like to see an opt in opt out if we can. I know that you've said it's more expensive, but as somebody who does have a car of their own, I'd be paying for a bus pass alongside the UNB parking fees, which is already at 170 for a whole semester. So, like, I would choose to opt out if I have that option, just because I could put that money towards a parking pass. And if the bus pass does up in price, which you say it will, and you did throw the number 170. That's equivalent. We're buying a parking pass anyway. So that's why I'm kind of thinking that the opt in opt out might be a good idea.

Sydney: I have the opposite end of the spectrum as someone who didn't get a car until their fourth year when we don't even need to go to school. I had to use the bus a lot of the time. And I do agree with Tyler that why should somebody like him have to pay for the bus pass when they don't use it? I feel like I have parked on campus before without a parking pass. I know it's kind of risky. But I feel kind of like bad for people. I feel like a burden as someone who uses a bus that other people have to pay because I need it. I don't know. I feel like the opt in opt out option is a good.

Sarah: I think those are valid points that have been brought forward. And I think that I just want to emphasize the executive's rationale for leaning towards the option that Matt outlined. I think that COVID, I guess, in a sense, works to our benefit. And that we still can get an opt out option without a substantial fee increase and is a short-term solution. But also, the contract would only be for X number of years. It would like the contract will expire and then they'll get renewed and however long. However, far in the future, I think it's two years or three years that they do them every time. So, I guess like, yeah, I think that that option is a middle ground between what both Tyler and Sydney said, where you still get the opt out. But you don't get the substantial fee increase. And students aren't forking a lot of money out of pocket, especially at a time where students don't necessarily have money to give. And I understand that if we want, you know, full opt in, opt out, and then students with cars would get to have that money back, then those students that don't have cars would have to pay more. But in this little COVID caveat option, neither of those things are issues, because students would get to opt out, there wouldn't be a substantial fee increase. So that's a little bit more of a background as to why the executives thought the way that we did. But again, as Matt said, this is everyone decision, it's not an executive decision. So yeah, that's a little bit more context. But I just wanted to throw that out there.

Jonah: I have a question. Like if we go in with the opt out would there be an option for students to pay in payments or in full. And I agree with Tyler for the opt in opt out, because it's not fair for non bus users to pay for something that you're not using.

Matt: So, I can answer that. So basically, the bus pass, the price is included in tuition payments. So, if you have a plan for tuition and stuff like that, it is paid out there, but in terms of just a fee, the same as Campus Trust would be the same as some of the other student fees. So that's how that is paid. And right now, it is I think it's one of the lower in Canada for bus passes, in terms of how much students pay. As mentioned, opt in opt out is something that we want. And I think the city knows that we would like to have it as well. But the logistics of it and coming from their end, they already run a few deficits with our bus pass, because they do give us a pretty good deal for students. And if we could have opted in or opt out at the same price, it'd be awesome. At the same time, though, it's going to be a substantial price increase for students, and we don't really have the exact number of how many students actually use the bus



right now. I would envision that it's a lot. But at the same time, it's gonna be a substantial price increase, but at the same time, it isn't everybody decision. And we definitely take your opinions into account for this kind of stuff.

Alaina: What I do is want to put forward having looked at bussing prices, we do still stand to benefit students, no matter which way we go. If students were to have to go get their own bus passes themselves, it does cost \$55 per month. So, like, we are still in the realm of it being better for students. I guess my question for you, Matt, is could you elaborate more on like this COVID clause? Is it something that would only be an option to us within a contract, if school remains like in a virtual setting, or a hybrid fashion, or this be a part of the contract for two years, regardless of which ways the school moves?

Matt: It would depend on public health and all that stuff for next year. So, if we were, if we were kind of in a virtual setting again, next year, I would have vision, we still have to work on the contract. But that type of clause the same as this year, where a possible reimbursement or a possible opt out, could be in play. But as mentioned, is a two-year contract. So, I don't think COVID will be around for two years, hopefully not. But in a second year, if everything's back to normal, then that would be in there just because it's kind of pending on public health in the state of school next year. So that's something that has to be worked out in the contract. But yeah, so it's not something that would be there for two years. That's for sure.

Sarah: I also want to add something, and I just remembered is that UNBSU Fredericton was talking with Fredericton Transit this year, looking at getting a bus pass because they don't currently have one. And they were looking towards an opt in slash opt out model. And they unfortunately had to just scrap the idea entirely because they couldn't work out a solution that was beneficial for students and for them with Frederickson Transit. So that's something that they entertained. That's all the information that I have. I don't have the specifics on what was the deal breaker, I guess for them, but I do know that that's something that they're looking at and that they're really passionate about. And unfortunately, they had to scrap it because it just, it didn't work out for them and their union and their students.

Sydney: Okay, now to contradict myself, I'm trying to see it from every end. So, if we did keep it as just as, everyone pays for it? How much is it again, in tuition?

Matt: I believe on university websites, it's around \$99. I don't know if that's specific, but I believe it's somewhere out there. But as mentioned, an opt in, would be the highest, which should be over \$200, at least, and then opt out would be at least \$175 starting out. And then after two or three years, it would get up to probably over \$200.

Sydney: Okay, because I know like when I used to take the bus, it would always be full of STU students. So, I'm wondering like, do the majority of students like is there a way to get a survey to see how many people take the bus or have taken the bus in the past? Because I know it's not being used probably as much now since we're in COVID. But if like, I will say 80% of students use it. The other 20% still matter. But it's like the fees kind of weigh out the cost, I guess, with 100% of students.

Matt: Yeah, that's definitely something that we kind of looked at when coming to the kind of rationale that we should just go with what we have right now. Because as you all know, we implemented the hotspot stuff last year, the online stuff for the bus pass, and as of right now, we don't have any statistics because it's such a new thing. Especially this year because this year they'd be all messed up because of COVID and stuff like that, people not in Fredericton. But that's why we kind of said in the meeting, we talked about it that we would love to have those kinds of statistics. But if we waited two years and then saw like, kind of the trends and stuff like that, as students using it routes, all that stuff, because it can gather that information, then a contract can be made for longer term based on those statistics. But right now, we only have one-year statistics or maybe a half year because I think it was implemented halfway



through two years ago, maybe. So, this year, we couldn't use those statistics. But that's one of the things that we took into account.

Sydney: And if we don't do the hotspot thing, or if we don't do, everybody pays if we do opt in or opt out? Is there a way that we could talk with UNBSU? And by maybe expanding Safe Ride grounds a little bit? Because I know that there's only a little bit a limited area where Safe Ride can go. So, I'm just trying to think of other options. If not, everybody needs the bus or wants to pay for it.

Sarah: Yeah, that's another reason why I guess the bus pass is beneficial for students is because it does go to the north side where Safe Ride doesn't. And if I remember correctly, it's liability reasons that surprise doesn't go that far. And so, I can't give a definite answer. That would be something in the cards to expand, where Safe Ride goes. So unfortunately, I can't give an answer on that. But I do know that I'm pretty sure it's for liability reasons. I don't think we could get a joint contract. I don't know if we'd be able to agree on that. To be honest, we both have a lot of differing needs for our student populations. But it's not worth not looking at. But anyways. Yeah, I think it is for liability reasons. And also, another thing to keep in mind with Safe Ride is it only goes one way. So Safe Ride can't come and pick you up from your house and bring you to campus. They can only take you from campus to a location. So, there's another limitation, I guess there. But it would be something maybe looking into again, as Matt said, we're really with a time crunch on this. So not to say that we shouldn't explore other options. But also, just keeping that in mind that this is kind of a quick decision, as I think a lot of things have been this year with COVID. And COVID is complicated a lot of things. And elections and stuff and just everything just crazy town this year. But yeah, those are some things to think about.

Matt: And one final thing I just want to say that the university also funds a big part of our bus pass. I don't think any other university does that. But they're looking to withdraw their funding from our bus pass. So that would cost more on the students end, and our end because the university has funded a bus pass for a while now. And they're looking to withdraw that funding maybe not all at once, but maybe over the course the next two, three years. So that's also something to take into account.

Alaina: I am a couple steps back, big oof on the University of pulling out funding. But I don't have thoughts collected together on that yet. I do support I think the original plan that was stated, of maintaining our status quo as much as possible about what things look like this year, just knowing that things are changing, and the situation's evolving. So just letting people out of the contract if they can, it's really nice. But I am very, very supportive of knowing that we need better numbers about what our buses do and who they serve us going forward. So, I'd really encouraged that. I do think that there's a big possibility that the culture of using our bus system may shift in the coming years knowing that Chatham and Rigby Hall will no longer be part of our campus. And I know that was a really important group that was served by being able to take the bus home into the campus.

Tyler: I'm just thinking like, if the university does rollback their funding, does that mean that it will no longer be included in our tuition payments? And it will be like a STUSU fee? That's part one of my question. And I'll have that answer first, hopefully.

Matt: So right now, technically it is a STUSU fee already in a manner, because it is a student union bus pass. So, I believe, I don't know the exact number, how much University pays into it, but it might be half, it could be a little less. But basically, if they rolled out their funding, which from what Reg has told me, they are going to for financial reasons and stuff like that. That means that it's going to be even more expensive for students and us to fund the bus pass.

Tyler: Okay, so my follow up, then is that we know that it's already going to get more expensive. Isn't that an argument in favor of having an opt out option? Because it will be even harder for some students to afford that on



top of all other costs? Like, yes, I know, that will drive up the option for other students as well. Like, I'm just trying to see how that would all work out in like in total?

Matt: Basically, even if it is going up, because of university going funding, it just gonna keep going up even more if we allow that to happen, you know, I mean, because if, say the university withdrew their funding, and the opt in would cost over \$200, that could add on another 40 to \$50 to it because right now, the University hasn't withdrawn their funding, but if they do, that, it would just be even more expensive.

Sarah: Yeah, I also want to say as well that like, the University withdrawing their funding, like if that were the case, I don't think in any scenario, should we have students bear the brunt of that cost. So that would come on the union. So that would take away funding for initiatives that we put on, like counselor initiatives, winter formal stuff like that. We're losing money there, emergency bursaries, all that stuff is it's going to take a hit, bearing the brunt of that funding, I guess. And obviously, as the price of the bus pass goes up, that is indirectly the cost that we will pay going up. Because I'm very adamantly against having students bear the brunt of that cost, or the university withdrawing their funding. I don't think that in any world that, you know, we should be doing our due diligence to help students financially and not say, okay, the university is not funding any more, surprise you need to pay extra money. I think that'd really not be a good decision.

Tyler: I just wanted to figure out like how that logistically would work on top of everything. So, thank you. It makes sense.

Sarah: I also just want to add as well, and this is, I guess, like an argument both in favor for keeping it the way that we currently have it and an opt in model, not an opt out model is that when Kyle and I receive emergency bursaries, quite a few of them indicate when students are in financial need, and they drive cars, they stopped driving their cars, and they start taking the bus to save money on gas to save money on, you know, car maintenance, stuff like that. So that's another thing that I don't think people commonly think about and relate that to the bus pass is that when students do face financial struggles, they use that as an opportunity to save money, and to put it towards rent, groceries, stuff like that. So that's not an argument in favor of opting out. Because once you opt out, you're done for good. Again, back in, but that would be I guess, an argument in favor of maintaining what we currently have and an opt in model.

Matt: So, I don't know if we really need to move a motion or if we should vote on it. I don't know. Basically, I just wanted to kind of bring it up for discussion to see if there was enough agreement with the rationale that the executives came up with to kind of maintain the status quo that Alaina mentioned and then wait for next year, because we don't know what it's going to be like. So, if it is kind of a hybrid model or virtual, or in person, at least we have options in front of us for next year, instead of being bonded into a contract that there is no clause like that. So that's one benefit of it. And then also, as mentioned, waiting for those statistics over those next two years. And I'd be hesitant to ask for a three-year contract, I think that's what the city of Fredericton will want. But I think two years would give us enough time to kind of see that and see how it's working and stuff like that. And like I said, I think an opt out opt in thing would be the best thing for students. But at this time, because of I don't know, the times we're living in, it's just if everything is to kind of uncertain for the next kind of six, seven months in the school, that they're in already having the option with the status quo. It seemed like a better fit for the kind of what we're going through right now. But like I said, maybe in one to two years and opt out could be pushed for. But right now, it seems like the city of Fredericton is pretty hesitant to give us the opportunity to have an opt in opt out model without charging us a lot of money for students. So yeah, that's kind of what I wanted to talk about. I think we kind of covered everything. If there's any other questions, I'd be glad to answer them though.

Andie: Yeah. So, for the proposal, is there any way that we could be sent the actual proposal or?

Matt: Like I said, it's due or not due, but they would like it by Wednesday. So, Sarah, and I can work on it tomorrow or the next day, and then send it out to everybody. And then if we get some feedback and stuff like that, then we can definitely look into including that in a proposal, because we do want to make this in a way that's beneficial for all students. And that's what we're trying to do here, especially with the uncertain time that lies ahead for universities and stuff like that.

7.4 Funding Application

Matt: So, the Finance Committee on some time last week, agreed that everything looked good in this funding application. It's on behalf of Leanne. It's on behalf of the Indigenous Students Reconciliation Committee. So, it's something that would come out of the probably the activities line because it's not really a clubs and societies, so it'll come out of that line. And basically, I think we've talked about it in the meeting so far. This is funding for the event series that the Indigenous Students Reconciliation has been putting on, titled The Indigenous Education Awareness series. So, a lot of you have probably seen it on social media and stuff like that throughout the week. And basically, they're looking for funding for like three guest speakers and the honorariums of \$125 \$125, and then \$250, so it come to a total of \$500. Like I said, the finance can be looked at it, and it looked all good to us. But because it is at \$500, the kind of threshold there, it had to be brought to SRC for approval. So, I will make a motion on behalf of the finance committee to approve this funding application for \$500 from the activities line, and then Brianna could open it up for discussion.

Jonah: Just had a quick question, since there's a conflict of interest for Tiger and I being part of that committee. Are we not voting on this? Are we excluded?

Matt: You can abstain if you want, but I think you can vote because you're on SRC and stuff like that. But if you want to abstain, then feel free to.

Sarah: I absolutely love that you asked that question. I love good governance. Yeah, I just wanted to say that and echo what Matt said. Also, for those who don't know, abstentions are for when you think you have conflict of interest, or if you are undecided on a matter, you can abstain. So, it's really up to your personal discretion, though. There's no I guess, right or wrong answer. It's personal opinion.

Motion has been moved by Vice President Administration upon the recommendation of the Finance Committee to approve the funding application for \$500 from the activities line.

Seconded by Sarah K.

That motion has been approved by present 9 voting members of council. 2 present voting members abstained from voting on the motion.

Jonah: Just want to say thank you guys for approving this and helping us out.

8. Questions, Announcements & Notices

Sarah: I just want to say, I alluded to that before we talked about the strategic plan but depending on how much discussion there is on the strategic plan tomorrow if we're able to approve it, then and no one else has anything that they'd like to be approved or brought to Council. Then I think of next week's meeting maybe our last meeting of the year. Very, very sad. It breaks my heart this year has gone by so quickly and it's crazy. That being, it would potentially be our last meeting of the year because like I said, our next meeting would fall on a holiday. And then we get into exams, and we don't meet during exams. Alaina: Yeah, just a quick one. Info sessions are happening for departments now. So, if you're in younger classes, or new people who are just starting off their journey who don't know what they want to take yet or major in, that is a great opportunity to connect with students. And I'm also happy to have anyone sent my way to talk about a program if they want to.

Jonah: I just want to add to my report. On that Monday, I had a meeting with the Indigenous Reconciliation Committee. And Friday afternoon, I attended the book launch for Augustine's book at JDH. And that's everything.

Andie: So, I'm not sure if this is like a stupid question. But I know the execs write transition documents. Is that a common practice for Reps?

Sarah: I love all these questions. So many good governance questions. It's mandatory, I guess for the execs to do. I wouldn't say it's common practice for counselors to do however, I think it's beneficial for counselors to do. The execs do like a really, really formal transition document. It's like very long, very procedural, very formal, that is not an expectation of any of you by any means. You're more than welcome to reach out to whoever's in coming into your position and maybe write them a little blurb and say, like, hey, like, here's some things that I think you should know.
