### 4. Executive Reports

#### 4.1 President's Report - Husoni Raymond

Hello everyone and welcome back another SRC meeting. It seems like it was just yesterday that we met, so the weeks are going by quite fast. So, since our last meeting, I had a senate committee on Indigenous Reconciliation meeting. I met with Jeffrey Carlton, Dr. Bateman and Dr. Jamie Gillies to discuss the Candidates Debate coming up tomorrow in the Kinsella Auditorium from 6:30 PM to 8:00 PM. I had a Search Committee meeting for a new Associate Vice President Research. So, I'm basically going to be on the hiring committee for that new person because the current person will not be renewing their contract. I had lunch at the Wabanaki center on Wednesday at 12:00 PM, which was really good. It's free lunch and everyone's invited, and it's a real good way to meet Indigenous students, like, I met so many new people that I've never seen on campus before, so that was a really good experience, and it's also really good food.

We had a SEC meeting and I had a meeting with the Elections Canada representative, just to go over special polling on our campus from October 5<sup>th</sup> to October 9<sup>th</sup>. We just discussed a lot of logistics around the special pulling, but one thing I'd like to highlight is that they are looking to hire poll workers for October 5<sup>th</sup> to October 9<sup>th</sup> and they are paying between \$15 to \$20 per hour, and I think they have four hour shifts and each person is expected to do at least three of those four hour shifts, so if you are interested, you can go on the Elections Canada website and apply, and it's right here on campus from October 5<sup>th</sup> to 9<sup>th</sup>, so it's not a huge time commitment. Pass it on, they're looking to have the training this weekend, so if you're interested you have to apply ASAP. Unfortunately based on what she told me, international students are not eligible to apply, but for all domestic students who want this opportunity, please go to the Elections Canada website and check that out, and also tell your friends.

I had my Help Desk office hour in JDH last Thursday, which was good. I also volunteered at the 203 last Thursday, as well, from 1:00 PM to 3:00 PM, which was really good. It was kind of quiet, but we had a couple visitors and I think it's going to be a real good opportunity to have the STUSU just be more active in the

centre in general cause traditionally we haven't had that good line of communication, so just to improve that, I'll be there every week - except for next week as I will be gone. I had a meeting with Redge Galant about the bus pass, just to discuss some concerns I've been hearing. We will be scheduling a follow up meeting with Fredericton transit, just to do a review of how it's been with the digital pass thus far, and if there is anyway we can make it better for students.

I had a call with the lawyer of the Workers' Union, just to go over some corrections in the current Collective Bargaining Agreement, so there are a number of typos and stuff, so she proposed to fix those and I went over them with her and we agreed and we also discussed the issue about employee salaries which we were able to clarify. The final vertical on that, is that - so, initially when they reached out, when that information was requested, I reached out to the lawyer immediately to see if there was anything in the agreement that prohibits this type of information from being disclosed. They did not get back to me until after the article was published, and they got back to me Tuesday night saying there's nothing that prohibits that and then I got back to them saying, well my understanding was that specific salaries were to remain confidential, but the general range was public and it has always been accessible on our website. Like, students can see the wage per hour, and also, the hours of work for each of our employees, so then I decided to release the information since they said that it was okay. Then the next day they got back to me and said that actually it might be a violation of the workers privacy if this information is disclosed. So, then I did my own research on it and there's nothing - they cited the Right to Information and Privacy Protection Act, I think, but that only applies to public institutions which the union is not public, like, we're not publicly funded. We are funded solely by student fees, so it wouldn't apply to us. So, I got back to them with that information, but upon further research I saw that it's common practice for even ununionized workers, for their salaries to be censored, so I decided to move forward with that and re-censoring the salaries, but put a range at the bottom of the salary chart - even though the range has always been accessible through the Collective Agreement, but just to make it easier, I put it at the bottom of the document. I also did an interview with the Aquinian to discuss that and provide some clarification on the entire process and why we decided to move forward that way.

I had a meeting with Chloe, just wrap up some stuff about Welcome Week. She sent me her transition document today, so that's great. We discussed the Welcome Week budget, and just wrapping up some loose ends, and overall Welcome Week was great. She will be coming in - she works on Monday nights, but she'll see if she can get a night off in the near future so she can come in and give like an official presentation or just talk about Welcome Week and the overview of the budget and stuff like that. This morning I had an Experiential Learning Committee meeting. We went over the funding chart from last year and just reviewing the budget, how much we have for internships this year, and discussed the faculty incentive fund in promoting Future Ready and Be on Our Campus.

After that I went to JD H and we officially launched the wall of brick campaign, so basically it is the Don't Cut Our Future campaign, but this is leading up to that - to the rally on Thursday. We're going to be meeting, in the quad, around 4:30 PM I believe, so we are really just mobilizing students, getting the word out. Thanks to Matt and Sarah for literally cutting out almost 200 brick squares with me last night, so today we got over 70 students to participate and talk about why New Brunswick needs a debt relief program. New Brunswick does not have a debt relief program, but we have above average student debt, so this is one of our major asks for the government. It is to implement an accessible debt relief program, so students either wrote their total student debt, or how student debt affects them, and it's supposed to symbolise how student debt is a barrier, or a wall, to accessing pos- secondary education, and so that was really fun. Tyler, thank you for stopping by even though you weren't scheduled, and helping out with getting people to participate, or sitting at the table while I walked around asking people to fill out the bricks. I was also sitting at the pledge table at the same time, so kinda balancing both of those, so I was there from around 10:00 AM to 3:00 PM.

Then I had a NBSA board meeting earlier later this evening where I took the minutes as the Vice-chair of the NBSA. I also worked on the NBSA's press release, that will be released this evening about the rally on Thursday, so that's really exciting. Please tell all your friends, share the Facebook page all about, and I hope all of you can commit to attending. Unfortunately, I won't be able to attend because I'll be gone for Moot Court, but I'm really hoping that we have a really good turn out there.

Yeah, most of my time over the past couple days have been focused on the Candidates Debate that is tomorrow. Also, hoping that most of you folks can attend. We did hear back from the conservative person today saying that they are unable to attend, unfortunately. So, they went back on their confirmation, but the debate will move on and everything is great with this debate other than that, so it's going really smoothly. I heard from CBC today, and they are interested in covering the debate, so they're sending someone tomorrow, so that's great.

I had a meeting with the president of the UNBSU, just to talk about the Don't Cut Our Future campaign and talk about how we'll be meeting up together on UNBSU campus and then marching downtown. We also talked about working collaboratively to have something done about the trail that connects UNB and STU. Probably having it renamed and installing some lights there, so they will be following up with their facilities people and then keeping us in the loop so we can organise on that. I'm not sure if I mentioned that I did an interview with the Aquinian about a follow up interview about the Workers' Union, and that is all for my report.

### 4.2 Vice-President of Administration's Report - Matthew Oram

Hi everyone, this week I've mostly been doing stuff over email, so like IT emails for the clubs and societies are still kind of an issue with Outlook for some reason. I don't really know why, but it's a lot more complicated than Gmail used to be, so I'm still trying to figure that out for a few clubs and societies.

Also, I know a few of you signed up for the Governance and Finance Committees, but I've also – I don't know if you saw it on the social media post today – that I've got a few people that are interested, so that's awesome. I'll be sending out an email to all of you in the next, probably, couple days to figure out a first meeting time. These are kind of on a need to basis, so we'll see about that.

Also, I kinda got the ball rolling with the nominations – Husoni will talk more about that later – but the nomination of the byelections that will start next week. For those of you that don't know the current vacancies we have, for Off-Campus Representative, Holy Cross, Vanier - that'll be figured out by itself with the houses, but the Indigenous Student Representative, the two First Year Representatives, and then Board of Governors Representative, as well, so hopefully we're able to fill all of those. And that will be starting Monday for nominations.

Also, I sat at the Get Out the Vote table a couple times. We've been getting lots of pledges. I also had my Help Desk office hours last Thursday at 10:00 AM. I also had a few emails regarding Campus Trust coverage from social work students, and also undergraduate students, regarding what they're covered by, and this week I will be doing a budget update for the month of September, so that'll be online towards the end of this week, probably, and that's it for me.

Tyler: Just for clarification, did you mention two First Year Reps?

Matt: Yeah, one for off-campus and one for residence.

#### 4.3 Vice President of Education's Report – Ailish MacKenzie-Foley

So, I read the minutes and we all say, "hi everybody," so, I need something different...so, hello peeps. So, my week started off with the Provincial Experiential Learning Steering Committee down at UNB, and I went with Elise from Mount A, we both represent the NBSA with that. It went really, really well, and there's more news to come on a gala that's happening for those who participated in Experiential Learning internships and whatnot. So, that will be really exciting.

We had our Dogs and Democracy event. It was great. It was simulated voting and petting therapy dogs. Two worlds into one, what could be better, dogs and democracy. Yes, so that was great. We got a lot of pledges from that, even some profs showed up. So, it was cool, and I even got them to pretend to vote. So that was also nice.

I met with Annie from CASA over the phone, and she's actually coming to our campus and UNB's campus tomorrow, just to help out with some events, check in with us on Get Out the Vote. We had our NBSA board meeting today, and as Husoni mentioned, our mobilization is happening this week, so participate, share, and that would be great. We have Dotmocracy and our Candidates Debate tomorrow, so again, we would love if all of you came out to that. The Get Out the Nope video is out, and people seem to be loving that one as well. All of our STUSU committees are posted, as Matt kinda mentioned before. Just a reminder that some of you, your positions are mandated, so to sit on some of these committees. So, if you get a random email from one of us its just because you're mandated if you didn't sign up for one.

The most exciting news is that we now have 442 pledges out of 500, our goal. So, that's 100 pledges since last weeks meeting, so really exciting. Yeah, that's it.

Ailish: I will also be attending the rally, so you can just look out for me, probably wearing this bright colour, so if you need directions down to the quad, we'll all be walking there together, so hit me up.

Husoni: Please invite all your Facebook friends. Please show up.

Tyler D: Last thing, is it being advertised on social media because I'm just a little curious cause personally, I can't speak for other people, but I haven't seen anything about the NBSA rally, and I find a lot of questions of "what is the NBSA rally" and I've had to explain to people, "Oh well it's sort of like a demonstration. We're marching down" all that, but I guess people have a lot more questions, I guess that could be answered on social media.

Husoni: Yeah, I created a Facebook event last week and we've been sharing - the NBSA directly has been sharing a lot of content - and we've been sharing it on the STUSU's Instagram and also the STUSU Facebook, so, like, obviously everyone wont see it on the social media, so that's where you all come in, with sharing within your networks, sharing the events within your respective groups to make sure the word gets out. And also we'll be doing the wall of brick throughout this week and we don't have like a set volunteer schedule, so if any of you are available and you see the table in JDH, you can help to like go around and give people bricks

to sign, and talk about their student debt or write their total amount, so we can make sure this campaign is successful.

Megan: So, just an idea, I don't know if this would work or not, but could you mention it tomorrow after the debate done, when there's a lot of people there since and its kind of political related?

Husoni: We'll consider.

#### 7.2 Nomination Committee

Husoni: So, one of my campaign platforms last year was enhancing the student experience and reviving the STU spirit kind of, so if you notice there are two new, and as I mentioned in my report over the summer, there are two new notice boards in JDH and one of them is STUSU profiles. So, we're going to be profiling students from academics, from athletics, we're going to be profiling faculty, staff. So, every month we'll have a new person highlighted for whatever they're doing in the community. So, I did not want to make the decision on who gets highlighted by myself. So, I think I'm gonna form, or I'm proposing to form, an unofficial nomination committee. So, if anyone's interested. So, we'll put out a call for nominations and then people nominate whoever they want, and then this committee will meet and review the nominations and then we'll decide who gets highlighted and then put them up. So, if anyone's interested in that, reach out to me, and then I'll write down your information and send you more information.

Dorcas: This is just a question, sow hen people are getting highlighted, do you do it for a month or per week cause I'm wondering how many people would we would be able to fit onto the board.

Husoni: It would be every month, just because I think weekly is too burdensome to do.

Dorcas: So, that would be, like, a total of eight people would be highlighted?

Husoni: More than eight people, but it would just change every month cause we have categories. So, we'd have like an athlete being highlighted every month, someone in academics or faculty being highlighted every month, someone from the Student Union being highlighted every month. So, you have an opportunity to be highlighted. Yeah, faculty, staff, students, academics, from every category someone will be highlighted.

### 7.3 Women's Centre Liaison

Sarah: Do you want me to put forth a motion first and then speak on it?

Brianna: We'd have to put it forward first, someone has to second it, and then we'll open it for discussion.

Husoni: It would be "be it resolved that \*BLANK\* be appointed as woman's centre representative on behalf of the STUSU, or if its university student."

Sarah: Okay, I want to put forth the motion that be it resolved that \*BLANK\* be appointed the woman's centre liaison for STUSU.

VPSL Sarah presented a motion to the council to appoint \*BLANK\* as Woman's Centre Liaison for STUSU. Seconded by Tyler D.

The motion was approved and opened for discussion.

Sarah: Okay. So, I'll explain like what it means so that you guys aren't like, what? Basically, every year we appoint - like within SRC - a women's center liaison. So, what this entails is basically you attend the women center meetings that are done at the SUB. They meet monthly, it's Wednesdays at 6:00 PM. I have all their

meeting dates for first semester, if you guys are interested in seeing that. Dorcas, I know you've been getting emails from them, but that's just because I had this position last year, so they have your contact information, but don't feel obligated to fill the position if you don't want to - if you want to that's excellent, but it's open to everyone. So, basically what it entails is you just attend the meetings and then you report what they're doing to the SRC and vice versa, you report what SRC does to the women's center, and yeah, you liaise between the two. It's pretty plain and simple. It's really, it's a really great position. They are great people down there and they do great stuff. Like I mentioned, I had the position last year. It's not - like, if you're worried about time commitment - it's really not that strenuous. Like, you just attend a meeting every month. I didn't find that it was that difficult to balance last year. Also, if you're worried, say like you would like to fill the position, but you're like, what if I miss a meeting yet...yada, yada. I'm also going to try and attend as many meetings as I can just to be there and just say, hey, what's going on? So, say in the event you can't attend a meeting, just to shoot me a message, I'm usually available at that time when they meet, so I'd be more than happy to attend a meeting and get the tea from them, but yeah, that's pretty much it. Yeah. If anyone has any questions or anything, feel free to ask.

Dorcas: How many liaisons would you have, just one?

Sarah: Yeah, just one. Also, if you're interested and there's more than one person interested, then we'd just have you say a little - or wait, no, actually should we table it and then let people think about it and then bring it up next meeting?

Husoni: Yeah, if you want. If people want time to think about it.

Sarah: How do I do this then? Do people feel that it would be best that we table it and then you guys can think about if you're interested or not and then bring it up next meeting, or do you feel that you're ready to put yourself out there?

Dorcas: I'm in favour of tabling it and discussing it next meeting.

VPSL Sarah made a motion to table the appointment of the women's centre liaison. Seconded by Tyler M.

The motion was approved, and the appointment of the women's centre liaison was tabled.

#### 8. Questions, Announcements & Notices

Kathleen: Just speaking on behalf of the French Association - I was asked by Professor Julien Defraeye to ask a couple questions to the executives because its about a new club and society. He was asking specifically what entails a quorum – especially for a small club, such as the French Society – and grounds for impeachment. That's generally what his questions were, so I said I'd ask them.

Husoni: So, a quorum is basically whatever the club decides in their constitution, but there is a clubs and societies policy on the website that outlines some basic stuff. For instance, you have to have at least three executive members, so that's something – it can't be less than three people. So, reading the policy would probably clarify that.

Kathleen: He did read the policy. He just wanted an average of what other clubs and societies have had in the past. He wouldn't take my assumptions.

Husoni: So, its however many people are interested, 50% of those people, plus one, so there's no set numbers. If it's only ten people apart of the club, quorum would be six because its five plus one. So, it just

depends on how many people are in the club. There's no mandated set quorum. And for impeachment, they'd have to come up their own guidelines as to what constitutes grounds for impeachment, and what that process is like – whether it's a majority vote by council, whether it's someone else on the executive team that has the authority to bring this forward or ask them when to resign. So, that's something they'd have to discuss because the Student Union doesn't impose that. If they want an example, they can look our bylaws or similar clubs from other universities, their bylaws, to see what they have laid out, but we basically can't tell them what their process should be.

Kathleen: Thank you for answering my silly questions.
